WHEREAS, the Marks included U.S. Trademark Registration No. 4,838,574 for the INDUSTRIAL CLIMATE ENGINEERING trademark.

WHEREAS, Assignor subsequently filed the additional trademark applications for the INDUSTRIAL CLIMATE ENGINEERING trademark in the United States and other countries and treaty organization set forth on Schedule A attached hereto, which additional trademark applications are owned by Assignee pursuant to the Agreement and the 2019 Trademark Assignment.

WHEREAS, Assignor and Assignee have prepared this Assignment for purposes of recording with the United States Patent and Trademark Office and, if necessary, corresponding agencies in other countries and under treaty organizations.




Assignor hereby requests the Commissioner of Patents and Trademarks, and the corresponding entities or agencies in any applicable foreign countries and under any treaty organizations, to record Assignee as the assignee and owner of the INDUSTRIAL CLIMATE ENGINEERING trademark applications and registration identified on Schedule A hereto.
