RELEASE OF SECURITY INTEREST

WHEREAS, Gibraltar Business Capital, LLC, a Delaware limited liability company, located at 400 Skokie Blvd., Suite 375, Northbrook, IL 60062 (the “**Secured Party**”), was granted a security interest in and lien upon all right, title and interest in, to and under the trademarks specified on Schedule A (“**Trademarks**”) by Revere Packaging Holdings, LLC, a Delaware limited liability company (“**Holdings**”), Revere Packaging, LLC, a Kentucky limited liability company (“**Revere**”), and Pearce Industrial Properties, LLC, a Kentucky limited liability company (“**Pearce**”) (Holdings, Revere, and Pearce hereinafter each individually and collectively, on a joint and several basis, referred to as the “**Debtors**”);

WHEREAS, the Debtors have requested that the Secured Party release and reassign its security interest in each of the Trademarks.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged:

1. Without recourse or representation or warranty, express or implied, of any kind or nature whatsoever, (a) the Secured Party hereby releases, relinquishes and discharges any and all liens and security interests in and to all of Debtors’ right, title and interest in, to and under the Trademarks, and (b) reassigns, regrants and reconveys to Debtors any and all of Secured Party’s right, title and interests (if any) in, to and under the Trademarks granted pursuant to the Security Agreement.
2. The Debtor has authorized Secured Party or its authorized representatives to record this Release of Security Interest (the “**Release**”) with the U.S. Patent and Trademark Office.
