ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS

This ASSIGNMENT OF SECURITY AGREEMENT (this “Assignment”), dated as of August 2, 2022, is by WELLS FARGO BANK, NATIONAL ASSOCIATION (individually, “WFB”), acting in its capacity as the current and resigning administrative agent (in such capacity, the “Resigning Agent”) and JPMORGAN CHASE BANK, N.A. (individually, “JPMorgan”), acting in its capacity as the successor administrative agent (in such capacity, the “Successor Agent”).

RECITALS:

ACUSHNET COMPANY, (as “Grantor”, and Resigning Agent are parties to Grant of Security Interest in Trademarks, dated July 28, 2016, recorded with the United States Patent and Trademark Office on July 28, 2016 at Reel 5841, Frame 0382 (as the same have been and may hereafter be amended, restated, supplemented or otherwise modified from time to time, the “Agreement”) covering certain intellectual property, together with the goodwill of the business symbolized by Grantor’s Trademarks, as set forth on Exhibit A attached hereto; and

WHEREAS, pursuant to that certain Second Amendment and Agency Resignation, Appointment and Assumption, dated as of August 2, 2022, by and among Acushnet Holdings Corp., as Holdings, Acushnet Company, as US Borrower, Acushnet Canada Inc., as Canadian Borrower, Acushnet Europe Ltd, as UK Borrower, WFB, as Resigning Agent, and JPMorgan, as Successor Agent, Resigning Agent has assigned to Successor Agent all of its rights, remedies, duties and other obligations under, among other documents, the Agreement, in each instance, in its capacity as administrative agent and, if applicable, collateral agent.

NOW, THEREFORE, in consideration of the foregoing, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Resigning Agent hereby assigns and transfers to Successor Agent and its successors and assigns, all of its rights, title and interest in and to the Agreement.


This Assignment may be executed in any number of counterparts, each of which when so executed shall be deemed an original and all of which taken together shall constitute one and the same instrument.
