**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of August 1, 2022 (“Release”), is made by Barings Finance, LLC, as Administrative Agent (“Administrative Agent”) in favor of Data Physics Corporation, a Delaware corporation, Lansmont Corporation, a California corporation, and Team Corporation, a Washington corporation (each a “Grantor”, and collectively, the “Grantors”).

WHEREAS, pursuant to that certain Guaranty and Security Agreement dated as of November 25, 2019 (as amended, supplemented or otherwise modified from time to time, the “Security Agreement”) by and among the Grantors, Administrative Agent, and others party thereto, and the Intellectual Property Security Agreement (Trademarks) dated as of November 25, 2019 by and among the Grantors and Administrative Agent (“Trademark Security Agreement”), each Grantor pledged, assigned and granted to the Administrative Agent, for the ratable benefit of the Lenders, a continuing security interest in, all of such Grantor’s right, title and interest in, to and under the Trademark Collateral; and

WHEREAS, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on November 25, 2019 at Reel 6804 Frame 0154.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Lenders, and Grantors agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement.

SECTION 2. Termination and Release. Administrative Agent, on behalf of the Lenders, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in, all of Grantors’ right, title and interest in, to and under solely the Trademark Collateral listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Trademark Security Agreement; and


(b) authorizes the recordation of this Release with the USPTO at Grantors’ expense.

SECTION 3. Choice of Law. This Release shall be governed by and construed in accordance with the laws of the State of New York.
