## Partial Release of Trademark Security Agreement

This Partial Release of Trademark Security Agreement, dated as of **August 3, 2022** (the "Release"), is made by Oaktree Fund Administration, LLC, as administrative agent (in such capacity, the "Administrative Agent") in favor of **Continental Intermodal Group – Trucking LLC, an Oklahoma limited liability company** and **Continental Intermodal Group LP, a Delaware limited partnership** (each, a "Grantor").

WHEREAS, by (i) that certain Guarantee and Collateral Agreement, dated as of **January 28, 2020** in favor of Administrative Agent (as amended, restated, or modified from time to time, the "Security Agreement") and (ii) that certain related Trademark Security Agreement, dated as of **January 28, 2020** in favor of Administrative Agent (as amended, restated, or modified from time to time, the "Trademark Security Agreement"; capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement, as applicable), which Trademark Security Agreement was recorded with the United States Patent and Trademark Office on **January 30, 2020** at Reel **6850** Frame **0703**, each Grantor granted to Administrative Agent, for the benefit of the Secured Parties, a lien on and security interest in all of such Grantor's right, title and interest in, to and under the Trademarks (as defined in the Security Agreement), including those Trademarks listed on Schedule I hereto (the "Released Trademarks");

WHEREAS, each Grantor desires Administrative Agent to release, discharge, terminate and cancel its lien on and security interest in the Released Trademarks;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent, on behalf of the Secured Parties, does hereby release, discharge, terminate and cancel any and all of its right, title and interest in and to the Released Trademarks, including any and all goodwill relating to the same, and assigns, transfers and conveys to such Grantor any and all of its rights, title and interests in the Released Trademarks.

The Administrative Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.


This Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
