FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, subject to the terms and conditions of the Indebtedness Cancellation Agreement, Agent hereby releases its liens on and security interests in the trademarks listed on Schedule 1 attached hereto and made a part hereof, which liens and security interests were established under and pursuant to that certain (i) Patent and Trademark Security Agreement, dated May 20, 2014, executed by the Company in favor of Agent and recorded with the United

States Patent and Trademark Office on May 21, 2014 at Reel/Frame 005284/0604, and (ii) Patent and Trademark Security Agreement, dated April 14, 2017, executed by Lux Global Label in favor of Agent and recorded with the United States Patent and Trademark Office on April 14, 2017 at Reel/Frame 006034/0050.
