**TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this "*Termination and Release*") is granted as of December 30, 2021 by **TIGER FINANCE, LLC**, a Delaware limited liability company (the "*Assignee*"), in favor of **OUTDOOR ADVENTURE BRANDS, LLC**, a Delaware limited liability company ("**OUTDOOR**"), **AUSTIN KAYAK, LLC**, a Delaware limited liability company ("**AUSTIN KAYAK**"), **SUMMIT SPORTS LLC**, a Delaware limited liability company ("**SUMMIT**"), **OAB ACK, LLC**, a Delaware limited liability company ("**OAB ACK**"), and **SNOW SPORTS DEALS, LLC**, a Delaware limited liability company ("**SNOW SPORTS**", and together with **OUTDOOR, AUSTIN KAYAK, SUMMIT AND OAB ACK** , each a "*Grantor*", and collectively the "*Grantors*")

**WHEREAS**, the Grantors executed and delivered an Intellectual Property Security Agreement dated as of September 29, 2021 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "*Grant*"; all capitalized terms used but not defined herein shall have the meaning set forth in the Grant), granting the Assignee a security interest in and lien on certain trademarks and trademark applications ("*Marks*") described therein, which was recorded with the United States Patent and Trademark Office ("*USPTO*") on September 30, 2021, at Reel 7437, Frame 0571;

**WHEREAS**, the Grantors have requested that the Assignee hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantors in, to and under all of the Marks as herein provided; and

**WHEREAS**, the Grantors have requested that the Assignee provide a document suitable for recording with the USPTO to evidence the release of the Assignee's security interests in and liens on the Marks as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:

1. terminates the Grant and releases, terminates and discharges all liens and security interests in the Grantors' right, title and interest in, to and under (i) the Marks, including without limitation those trademarks, trademark licenses and trademark applications identified in Schedule A hereto, (ii) all proceeds and products of the Marks, (iii) all goodwill associated therewith, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same; and assigns, transfers and conveys to Grantors any interest in all of the foregoing, including any lien and security interest thereof; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.
