**TERMINATION AND RELEASE OF
AMENDED AND RESTATED INTELLECTUAL PROPERTY SECURITY
AGREEMENT**

This **TERMINATION AND RELEASE OF AMENDED AND RESTATED INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this "*Termination and Release*") is granted as of August 5, 2022 by **SILICON VALLEY BANK**, as Administrative Agent, a California corporation, with a loan production office located at 3003 TASMAN DRIVE, HF 150, SANTA CLARA, California 95054 ("**Bank**"), in favor of **DELPHIX CORP.** ("**Grantor**").

WHEREAS, the Grantor executed and delivered an Amended and Restated Intellectual Property Security Agreement, dated as of September 28, 2018 (the "**Agreement**"), granting to the Bank a security interest in all of its right, title and interest, whether presently existing or hereafter acquired, in, to and under the Patents (as defined in the Agreement), notice of which was recorded with the United States Patent and Trademark Office ("**USPTO**") on October 1, 2018 at Reel 047169, Frame 0863, and the Trademarks (as defined in the Agreement), notice of which was recorded with the USPTO on October 1, 2018, at Reel 6467, Frame 0228. The Agreement amended and restated in its entirety that certain Intellectual Property Security Agreement dated as of February 28, 2017 between Grantor and Bank recorded with (i) the Patent division of the United States Patent and Trademark Office on February 28, 2017 at Reel 041398, Frame 0119 and (ii) the Trademark division of the United States Patent and Trademark Office on February 28, 2017 at Reel 5999, Frame 0261.

WHEREAS, Grantor has requested that Bank hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Patents and Trademarks as herein provided; and

WHEREAS, Grantor has requested that the Bank provide a document suitable for recording with the USPTO to evidence the release of the Bank's security interests in and liens on the Patents and Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Bank hereby:

1. terminates the Agreement and releases, terminates and discharges fully all liens and security interests thereunder in Grantor's right, title and interest in, to and under the Intellectual Property Collateral (as defined in the Agreement), including, without limitation, those patents and patent applications identified in Schedule I hereto and those trademarks and trademark applications identified in Schedule II hereto; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.
