## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of August 5, 2022 (“Release”), is made by Bank of America, N.A. as agent (“Agent”) in favor of Radiant Logistics, Inc., a Delaware corporation, Radiant Global Logistics, Inc., a Washington corporation, Radiant Transportation Services, Inc., a Delaware corporation, Radiant Logistics Partners LLC, a Delaware limited liability company, Adcom Express, Inc., a Minnesota corporation, Radiant Customs Services, Inc., a Washington corporation, DBA Distribution Services, Inc., a New Jersey corporation, International Freight Systems (of Oregon), Inc., an Oregon corporation, Radiant Off-Shore Holdings LLC, a Washington limited liability company, and Green Acquisition Company, Inc., a Washington corporation (each a “Grantor”, and individually and collectively, jointly and severally, the “Grantors”).

**WHEREAS**, pursuant to that certain Loan and Security Agreement dated as of August 9, 2013 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”) by and among the Grantors, Agent, and others party thereto, and the Trademark Security Agreement dated as of August 9, 2013 (“Trademark Security Agreement”) by and among the Grantors and Agent, each Grantor granted, assigned and pledged to Agent, on behalf of the Secured Parties, a continuing first priority security interest in all of such Grantor’s right, title and interest in, to and under the Trademark Collateral; and

**WHEREAS**, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on August 15, 2013 at Reel 5092 Frame 0335.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent, on behalf of the Secured Parties, and Grantor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement.

**SECTION 2. Termination and Release.** Agent, on behalf of the Secured Parties, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges, and releases the first priority security interest in all of each Grantor’s right, title and interest in, to and under the Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Trademark Security Agreement; and

(b) authorizes the recordation of this Release with the USPTO at Grantors’ expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of California.

**SECTION 4. Acknowledgement.** The release of security interest granted herein expressly does not include a release of the security interest granted pursuant to the Security and Pledge Agreement dated as of August 5, 2022 (as amended, restated, amended and restated, supplemented, extended or otherwise modified from time to time) by and among the Grantors, Bank of America, N.A., in its capacity as administrative agent thereto, and others party thereto.

**IN WITNESS WHEREOF**, the Administrative Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
