GRANT OF SECURITY INTEREST IN
PATENTS AND TRADEMARKS

FOR GOOD AND VALUABLE CONSIDERATION, receipt and sufficiency of which are hereby acknowledged, **MARINEMAX, INC.**, a Florida corporation (“MarineMax”), **KCS RE ACQUISITION COMPANY, LLC**, a Wisconsin limited liability company (“KCS”), and **NORTHROP & JOHNSON HOLDING LLC**, a Florida limited liability company (“NJH”; together with MarineMax and KCS, the “Grantor”) on this 8th day of August, 2022, hereby grant to **MANUFACTURERS AND TRADERS TRUST COMPANY**, as the Administrative Agent (in such capacity, the “Grantee”), for the ratable benefit of the Credit Parties, a continuing first priority security interest in and Lien on all of the right, title and interest of the Grantor in all of the following property whether now owned or at any time hereafter acquired or created by the Grantor or in which the Grantor now has or at any time in the future may acquire any right, title or interest, as collateral security for the prompt and complete payment in full and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Obligations (as such term is defined in the Guarantee and Collateral Agreement referred to below): (i) the Trademarks set forth on Schedule A attached hereto (collectively, the “Trademark Collateral”); (ii) the Patents set forth on Schedule B attached hereto (collectively, the “Patent Collateral”), (iii) all Proceeds (as such term is defined in the Guarantee and Collateral Agreement referred to below) of the Trademark Collateral and Patent Collateral, and (iv) all IP-Related Rights (as such term is defined in the Guarantee and Collateral Agreement referred to below) of the Trademark Collateral and Patent Collateral.


THIS GRANT OF SECURITY INTEREST (this “Grant”) as collateral security for the prompt and complete payment in full and performance when due (whether at the stated maturity, by acceleration or otherwise) of the Obligations (as such term is defined in the Guarantee and Collateral Agreement referred to below), as such term is defined in that certain Guarantee and Collateral Agreement among Grantor, the other grantors from time to time party thereto and the Grantee, dated as of August 8, 2022 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the “Guarantee and Collateral Agreement”). All initially capitalized terms used but not otherwise defined herein have the meanings given to them in the Guarantee and Collateral Agreement.

This Grant has been granted in conjunction with the security interest granted to the Grantee under the Guarantee and Collateral Agreement. The rights and remedies of the Grantee with respect to the security interest granted herein are without prejudice to those set forth in the Guarantee and Collateral Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Grant are deemed to conflict with the Guarantee and Collateral Agreement, the provisions of the Guarantee and Collateral Agreement shall govern. This Grant may be executed in counterparts (including by telecopy or in electronic (i.e., “pdf” or “tif”) format) and all of said counterparts taken together shall be deemed to constitute one and the same instrument.


