For the purpose of converting VistaPharm, Inc., an Alabama corporation, into a limited liability company under Sections 10A-2A-9.01 *et seq.* of the Alabama Business and Nonprofit Entity Code (the "Entities Code"), the undersigned does hereby sign and adopt this Statement of Conversion.

1. The converting entity is VistaPharm, Inc., an Alabama corporation (the "Converting Entity"), with its principal office at 200 Connell Drive, Berkeley Heights, NJ 07922.
2. The Articles of Incorporation of the Converting Entity were filed with the Judge of Probate of Shelby County, Alabama, on February 27, 1998. The Alabama Entity ID number for the Converting Entity is 193-910.
3. The name of the converted company shall be VistaPharm, LLC (the "Company"). The Company is being converted from the Converting Entity to an Alabama limited liability company pursuant to Sections 10A-1-8.01 and 10A-2A-9.01 *et seq.* of the Entities Code.
4. There is at least one member of the Company.
5. The location and mailing address of the initial registered office of the Company shall be 4037 US Hwy 231, Suite A, Wetumpka, AL 36093. The initial registered agent at such address shall be InCorp Services, Inc.
6. The conversion of the Company from an Alabama corporation to an Alabama limited liability company was approved in accordance with Section 10A-2A-9.12 of the Entities Code.
7. The conversion and the existence of the Company under the name set forth above shall be effective upon the filing of this Statement of Conversion.
8. A copy of the Plan of Conversion will be furnished by the Company, on request and without cost, to any former stockholder of the Converting Entity.
