TERMINATION OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of May 31, 2022 (this "Termination"), is made by ARES CAPITAL CORPORATION, a Maryland corporation, as collateral agent (in such capacity, including any successor thereto, the "Collateral Agent") for the Secured Parties under that certain Trademark Security Agreement, dated as of October 10, 2018 (as amended, supplemented or modified and in effect from time to time, the "Trademark Security Agreement") by LIFECUBBY LLC, a Delaware limited liability company (the "Grantor"), in favor of the Collateral Agent. Except as otherwise provided herein, capitalized terms used herein but not otherwise defined have the meanings set forth (or incorporated) in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement, the Grantor granted to the Collateral Agent, for the benefit of the Secured Parties, a security interest in all of the Grantor's right, title and interest in, to and under all of its Trademark Collateral, including, without limitation those set forth on the attached Schedule A;

WHEREAS, pursuant to the Asset Purchase Agreement, dated as of the date hereof, by and among Procure Software, LLC, the Grantor and Excelligence Learning Corporation, the Grantor has disposed of the Trademark Collateral set forth on the attached Schedule A; and

WHEREAS, the Grantor has requested, and the Collateral Agent has agreed to provide, a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (the "Released Collateral").


NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Collateral Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the security interest created under the Trademark Security Agreement in the Released Collateral, (b) release its security interest in the Released Collateral, and (c) discharge any and all rights, title and interest it has in, and the security interest granted to the Collateral Agent in, the Released Collateral.
