RELEASE OF SECURITY INTEREST

This Release of Security Interest is made as of September 1, 2022, by COMERICA BANK, a Texas banking association ("Bank") in favor of DRAWBRIDGE PARTNERS, LLC, a Delaware limited liability company ("Grantor") with its principal place of business located at 1350 Avenue of the Americas, 2nd Floor, New York, NY 10019.

Recital

WHEREAS Grantor granted to Bank a security interest in the trademarks described on Exhibit A attached hereto (the "Intellectual Property Collateral") under an Intellectual Property Security Agreement dated as of October 13, 2021, by and between Grantor and Bank, as amended from time to time (the "Security Agreement") and recorded with the US Patent and Trademark Office as set forth on Exhibit A.

WHEREAS Grantor has no outstanding obligations to Bank under the terms of the Security Agreement, Bank agrees to release its security interest in the Intellectual Property Collateral.

Agreement

Now therefore, Bank (1) agrees that it terminates and releases its security interest in the Intellectual Property Collateral and reassigns to Grantor, without warranty or recourse, all interest of Bank in the Intellectual Property Collateral, and (2) authorizes the United States Patent and Trademark Office to register the release of the security interest.
