INTELLECTUAL PROPERTY ASSIGNMENT

For the avoidance of doubt, Assignor hereby assigns to Assignee all rights and assets associated solely with the trademarks COMPASS RV PROTECTION and COMPASS MARINE in its possession, even if not specifically named herein except any rights and assets associated with the products, services and offerings of Assignor bearing the trademarks or Brands.
