WHEREAS: -


1. The Assignor was the registered proprietor and owner of certain IP rights.
2. The Assignee has acquired from the Assignor the IP rights by the Italian Court's assignment after bankruptcy dated 12.02.2018 among which the trademarks listed under the Schedule A hereunder at the bottom (hereinafter "The Trade Marks").

IT IS CONFIRMED THAT:

1. The Assignee has acquired from the Assignor all its property right title and interest in and to the Trade Marks, together with the whole of the goodwill attached to the Trade Marks and the goodwill of the business in the goods to which the Trade Marks are applied associated with;
 - a) as well as all rights attached to the Trade Marks and the right to sue for past infringements including for passing off or unfair competition, and to retain recover any damages, interest, profits and costs awarded.
2. The Assignor hereby covenants with the Assignee to execute all such documents, forms and authorizations and make or swear any declaration or oath as may be required by the Registrar of Trade Marks for vesting the full right title and interest to the Trade Marks in favor of the Assignee.
