TERMINATION OF
COLLATERAL AGREEMENT

This TERMINATION OF TRADEMARK SECURITY AGREEMENT (this "Termination"), dated as of August 11, 2022, is made by JEFFERIES FINANCE LLC, as collateral agent (in such capacity, together with any successors and assigns in such capacity, the "Collateral Agent"), in favor of REDBOX AUTOMATED RETAIL, LLC ("Grantor") in connection with the termination of that certain Collateral Agreement, dated as of September 27, 2016 ("Collateral Agreement") among Grantor, as successor by merger to Redwood Merger Sub, Inc, each subsidiary of the Grantor identified therein and the Collateral Agent as collateral agent for the Secured Parties (as defined therein).

WHEREAS, the Notice of Grant of Security Interest in Trademarks was recorded with the United States Patent and Trademark Office for the trademarks (collectively, the "Collateral") set forth on Schedule I hereto, having the registration numbers indicated on Schedule I hereto, on the dates indicated on Schedule I hereto, at the reels and frames indicated on Schedule I hereto; and

WHEREAS, as a result of the termination of the Collateral Agreement, the Collateral Agent has agreed to release all of its security interest in the Collateral.


NOW, THEREFORE, for valuable consideration, the Collateral Agent hereby (i) agrees, acknowledges and affirms that the Collateral Agreement is terminated, (ii) discharges, cancels and fully and unconditionally releases the collateral pledge, grant, mortgages, liens, collateral assignments, security interest, and all right, title and interest in, to, and under the Collateral, including, without limitation, those Trademarks identified on Schedule I hereto, (iii) without recourse, representation or warranty, reassigns, transfers, sets over and reconveys to the Grantor all of such Grantor's right, title and interest in and to the Collateral subject to said Collateral Agreement and (iv) authorizes the Grantor to record this Termination with the United States Patent and Trademark Office.

This Termination is governed by the laws of the State of New York.


