CONFIRMATION ASSIGNMENT OF REGISTERED TRADEMARK

NOW, THEREFORE, on or about October 18, 2021 for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns to Assignee all right, title and interest in and to the Trademarks, and the goodwill associated therewith, together with all related common law rights, the right to register, renew, protect and defend the Trademarks and the right to sue for past infringements of the Trademarks. Assignor agrees to cooperate with Assignee to record this Assignment in the United States Patent and Trademark Office and to extend such other cooperation and perform such other acts as may be reasonably necessary to convey, establish, evidence, maintain, defend and enforce Assignee’s rights in the Trademarks; and Assignor hereby irrevocably appoints Assignee and any of its officers as Assignor’s attorney in fact to undertake such acts in Assignor’s name.
