**RELEASE OF SECURITY INTEREST
IN INTELLECTUAL PROPERTY**

This Release of Security Interest in Intellectual Property, dated as of August 15, 2022 (the “**Release**”), is made by **MIDCAP FUNDING IV TRUST**, a Delaware statutory trust, (“**Agent**”), in favor **RADIUS HEALTH, INC.**, a Delaware corporation, and **RADIUS PHARMACEUTICALS, INC.**, a Delaware corporation (each, a “**Grantor**” and collectively, the “**Grantors**”):

WHEREAS, pursuant to that certain Intellectual Property Security Agreement, dated as of January 10, 2020, as amended by that certain Omnibus Reaffirmation Agreement and Joinder and Amendment to Pledge Agreement and Intellectual Property Security Agreement, dated as of March 3, 2021 (as may have been further amended, modified, restated, replaced or supplemented from time to time, the “**IP Security Agreement**”; capitalized terms used herein have the definition provided for in the IP Security Agreement), recorded with the United States Patent and Trademark Office (the “**USPTO**”) on January 15, 2020 at Reel/Frame No. 51618/758 (Patents) (as supplemented by (i) that recording on July 6, 2020 at Reel/Frame No. 53131/465 (Patents), (ii) that recording on March 17, 2021 at Reel/Frame No. 55632/634 (Patents) and (iii) that recording on March 17, 2021 at Reel/Frame No. 55632/316 (Patents)) and on January 15, 2020 at Reel/Frame No. 6838/837 (Trademarks) (as supplemented by (i) that recording on July 6, 2020 at Reel/Frame No. 6991/87 (Trademarks), (ii) that recording on March 17, 2021 at Reel/Frame No. 7223/184 (Trademarks) and (iii) that recording on March 17, 2021 at Reel/Frame No. 7223/221 (Trademarks)), the Grantors granted Agent, on behalf of the Lenders, a security interest in and to all of its right, title and interest in all of the Grantors’ intellectual property, including those listed on Schedules A and B thereto;

WHEREAS, the Grantors have requested that Agent release its security interest in and to the patent assets as more particularly described on Schedule A attached hereto (the “**Released Patents**”).

WHEREAS, the Grantors have requested that Agent release its security interest in and to the Trademarks as more particularly described on Schedule B attached hereto (the “**Released Trademarks**”, and together with the Released Patents, the “**Released IP Collateral**”).

NOW, THEREFORE, Agent, without recourse, representation or warranty and at the Grantors’ sole cost and expense, hereby releases all of its right, title and interest in and to the Released IP Collateral.


