## **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of August 5, 2022 ("Release"), is made by Saratoga Investment Funding LLC, a Delaware limited liability company, as Agent ("Agent") in favor of Jobvite, Inc., a Delaware corporation, Hireku Inc., a Delaware corporation, and NXTThing RPO LLC, an Ohio limited liability company (collectively, jointly and severally, "Grantors" and each individually "Grantor").

**WHEREAS**, pursuant to that certain Guaranty and Security Agreement, dated as of July 6, 2021 (including all annexes, exhibits or schedules thereto, as from time to time amended, restated, supplemented or otherwise modified, the "Security Agreement") by and among the Grantors, Agent, and others party thereto, and the Trademark Security Agreement dated as of July 6, 2021 by and among the Grantors and Agent ("Trademark Security Agreement"), each Grantor unconditionally granted, assigned, and pledged to Agent, for the benefit of each member of the Lender Group ("Secured Parties"), to secure the Secured Obligations, a continuing security interest in all of such Grantor's right, title and interest in and to the Trademark Collateral; and

**WHEREAS**, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office ("USPTO") on July 6, 2021 at Reel 7347 Frame 0409.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent, on behalf of the Secured Parties, and Grantor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Trademark Security Agreement.

**SECTION 2. Termination and Release.** Agent, on behalf of the Secured Parties, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in all of each Grantor's right, title and interest in and to the Trademark Collateral, including, but not limited to, the Trademarks listed on Schedule A attached hereto, granted pursuant to the Security Agreement or Trademark Security Agreement;

(b) terminates and cancels the Trademark Security Agreement; and

(c) authorizes the recordation of this Release with the USPTO at Grantors' expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.

**SECTION 4. Counterparts.** This Release may be executed in any number of counterparts and by different parties in separate counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Signature pages may be detached from multiple separate counterparts and attached to a single counterparty.

**IN WITNESS WHEREOF**, the Agent, on behalf of the Secured Parties, has caused this Release to be duly executed as of the date first set forth above.
