TERMINATION AND RELEASE OF SECURITY INTEREST

This **TERMINATION AND RELEASE OF SECURITY INTEREST** (this "*Termination and Release*") is granted as of August 15, 2022, by **CADENCE BANK**, (the "*Lender*"), in favor of **ARK NATURALS COMPANY**, a Delaware corporation (the "*Grantor*").

WHEREAS, the Grantor executed and delivered the Intellectual Property Security Agreement, dated as of October 27, 2017 (the "*Grant*"), granting the Lender a security interest in and lien on certain Intellectual Property Collateral (as defined in the Grant, the "*IP*") described therein, which was recorded with the United States Patent and Trademark Office ("*USPTO*") on October 27, 2017, at Reel 0006191, Frame 0656;

WHEREAS, the Grantor has requested that the Lender hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all of the IP as herein provided; and

WHEREAS, the Grantor have requested that the Lender provide a document suitable for recording with the USPTO to evidence the release of the Lender's security interests in and liens on the IP as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Lender hereby:

1. terminates the Grant and releases, terminates and discharges all liens and security interests in the Grantor's right, title and interest in, to and under (i) the IP, including, without limitation, those trademarks and trademark applications identified in Schedule A hereto, (ii) all proceeds and products of the IP, (iii) all goodwill associated therewith, and (iv) all causes of action arising prior to or after the date hereof for infringement of any of the IP or unfair competition regarding the same; and assigns, transfers and conveys to Grantor any interest in all of the foregoing, including any lien and security interest thereof; and
2. authorizes and requests that this Termination and Release be recorded with the USPTO.
