TRADEMARK ASSIGNMENT

This Trademark Assignment (the "Assignment") is made and entered into effective the 14th day of June, 2022, by and between Moketa, Inc., a California corporation with a place of business at 835 Locust Avenue, Unit 325, Long Beach, California 90813 (the "Assignor"), and Wrangler Apparel Corp., a Delaware corporation, with a place of business at 3411 Silverside Road, Wilmington, Delaware 19810 (the "Assignee") (collectively, the "Parties).

WITNESSETH:

WHEREAS, Assignor is the owner of the trademark CASEY JONES which is the subject of United States federal trademark Registration No. 6419640 (hereinafter, the "Trademark");

WHEREAS, Assignor desires to assign to Assignee all of Assignor's right, title and interest in and to the Trademark, including common law rights, together with the goodwill of the business symbolized by the Trademark; and

WHEREAS, Assignee desires to acquire all right, title and interest in and to the Trademark, including common law rights, together with the goodwill of the business symbolized by the Trademark.

NOW, THEREFORE, in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Parties agree as follows:

1. Assignment. Assignor hereby grants, assigns and conveys to Assignee all of its right, title, and interest in and to the Trademark, including common law rights, together with the goodwill of the business symbolized by the Trademark. Assignee hereby accepts the Assignment of the Trademark as described herein.
2. Cooperation. Assignor agrees to execute, acknowledge and deliver, or cause to be executed, acknowledged or delivered, such further instruments and documents and to perform such further acts as may be reasonably requested by Assignee to effectuate more fully the transactions contemplated by this Assignment.

3. Binding Effect. The terms, covenants and provisions of this Assignment shall inure to the benefit of Assignee, its successors, assigns and other legal representatives, and shall be binding upon Assignor, its successors, assigns and other legal representatives.
