

TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (the "Agreement") is made effective as of August 17, 2022 by and between Lockton, Inc., a Missouri corporation ("Assignor"), and Mylo ManagerCo, LLC, a Missouri limited liability company ("Assignee"). Assignor and Assignee may be collectively referred to herein as the "Parties."

RECITALS

WHEREAS, Assignor owns all right, title, and interest in and to the trademarks set forth in Schedule A (the "Marks");

WHEREAS, Assignor desires to assign and Assignee desires to acquire Assignor's right, title, and interest in and to the Marks together with all of the goodwill of Assignor's business symbolized by or associated with them;

NOW THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged

AGREEMENT

- 1.1 <u>Assignment</u>. Assignor hereby assigns, transfers and conveys to Assignee all of its right, title and interest in and to the Marks, including without limitation any and all registrations, applications, and/or common law rights, together with all of the goodwill of Assignor's business symbolized by or associated with the Marks, and any and all income, royalties, damages and payments now or hereafter due and/or payable with respect thereto including, without limitation, damages and payments for past, present or future infringements.
- 1.2 <u>Future Cooperation</u>. The Parties agree to execute such additional documents and perform such further acts as may be reasonably necessary to effectuate the purposes and provisions of this Agreement.
- 1.3 <u>Waiver</u>. The failure of a Party hereto to enforce, or the delay by a Party hereto to enforce, any of its rights under this Agreement shall not be deemed a continuing waiver or a modification by such Party of any of its rights under this Agreement. Either Party may, within the time provided by applicable law, commence appropriate proceedings to enforce any or all of its rights under this Agreement, and any prior failure to enforce or delay in enforcement shall not constitute a defense.
- 1.4 <u>Binding Upon Successors</u>. This Agreement shall be binding upon and inure to the benefit of the Parties and their officers, subsidiaries, agents, legal representatives, successors, assigns, and licensees.
- 1.5 <u>Recordation</u>. Each Party can, at its sole option, record this Agreement with United States Trademark Office.

1.6 <u>Counterparts</u>. This Agreement may be executed in any number of identical counterparts, any or all of which may contain signatures of less than all of the Parties, and all of which shall be construed together as a binding instrument.
