RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks, dated as of July 1, 2022 (the “Trademark Security Release”), is made by Christopher A. Yeung (“Yeung”), an individual residing at 6845 E. Solcito Lane, Paradise Valley, AZ 85253, SKW Partners LP (“SKW LP”), a Texas Limited Partnership located at 1320 W. Walnut Hill Ln, Irving, TX 75038, and Attn: Ms. Sherri Bennett, Spinalgenics, LLC (“Spinalgeneics”), a Washington Limited Liability Company C/O Jeffrey Roh and Jeffrey Roh (“Roh”), an individual residing at 1920 4th Avenue #2302, Seattle, WA 98101 (Roh and with Spinalgeneics, the “Roh Parties”) (Yeung, SKW LP, and the Roh Parties are collectively referred to herein as the “Secured Parties”), in their capacities as the Secured Parties under that certain Grant of Trademark Security Interest, dated as of September 30, 2021 (the “Security Agreement”), by and between Amit Govil (“Govil”), an individual, Scott Cadotte (“Cadotte”), an individual, Biologica Technologies LLC, a Delaware limited liability company (“Biologica”), and Advanced Biologics LLC (“ABC”), a California Limited Liability Company (Govil, Cadotte, Biologica and ABC are collectively referred to herein as the “Debtors”), and the Secured Parties. Except as otherwise provided herein, capitalized terms used herein but not otherwise defined have the meanings set forth (or incorporated) in the Security Agreement.

WHEREAS, pursuant to the Security Agreement and as evidenced by the Notice of Grant of Security Interest in Trademarks (the “Notice of Trademark Security Interest”), which was recorded in the records of the United States Patent and Trademark Office on October 18, 2021 at reel 7454, frame 0843, the Debtors granted to the Secured Parties, a Lien on and security interest in all of Debtors’ right, title and interest in, to and under the Trademark Collateral;

WHEREAS, the Debtors have requested and the Secured Parties have agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest and Lien on all Debtors’ right, title and interest in, to and under the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Secured Parties hereby agree as follows:

For purposes of this Trademark Security Release, “Trademark Collateral” means the following, whether existing as of the date of the Security Agreement or thereafter created or acquired all of the Debtors’ right, title and interest in, to and under all the following Collateral of the Debtors:

- (a) all Trademarks and applications thereof, including those listed on Schedule I attached hereto;
- (b) all goodwill associated with the foregoing; and
- (c) all proceeds of any and all of the foregoing.

The Secured Parties in each case, without recourse, representation or warranty of any kind whatsoever, hereby terminate, release and discharge (a) the Liens and security interest

created under the Security Agreement in the Trademark Collateral, and (b) the entirety of their security interest in all of Debtors' right, title and interest in, to and under the Trademark Collateral and any such right, title and interest of the Secured Parties, if any, shall hereby terminate, cease and become void.

Governing Law. This Trademark Security Release and the rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with, the laws of the State of California without regard to conflict of laws principles thereof that would result in the application of any other law.


