**TERMINATION AND RELEASE OF SECURITY  
INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of August 18, 2022 ("Release"), is made by **Wells Fargo Bank, National Association**, in its capacity as administrative agent for the Lenders ("Administrative Agent"), in favor of **Paper Partners Wipes, LLC**, a Delaware limited liability company ("Grantor").

**WHEREAS**, pursuant to that certain Trademark Security Agreement dated as of November 27, 2013, among Grantor, Albaad USA, Inc., North Carolina corporation, and Administrative Agent (the "Security Agreement"), Grantor granted to the Administrative Agent, for the benefit of the Lender Group and the Bank Product Providers, a continuing security interest in all right, title and interest of Grantor in and to all Trademark Collateral, including the trademarks identified on the attached Schedule A; and

**WHEREAS**, the security interest identified herein was recorded with the United States Patent and Trademark Office ("USPTO") on December 4, 2013, at Reel 5167 Frame 0327.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent, on behalf of the Lender Group and the Bank Product Providers, and Grantor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement referenced in the preamble and recitals hereto.

**SECTION 2. Termination and Release.** Administrative Agent, on behalf of the Lender Group and the Bank Product Providers, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:


- (a) terminates, cancels, discharges and releases the continuing security interest in, Grantor's right, title, and interest in and to the trademarks identified on Schedule A attached hereto, granted pursuant to the Security Agreement; and
- (b) authorizes the recordation of this Release with the USPTO at Grantor's expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of Georgia.
