## TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of August 18, 2022 ("Release"), is made by Fifth Third Bank, National Association, as successor to Fifth Third Bank, an Ohio banking corporation ("Bank"), in favor of Fashion Seal Corporation, a Nevada corporation ("Grantor").

**WHEREAS**, pursuant to that certain Amended and Restated Security Agreement dated as of March 8, 2016 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement"), by and between the Grantor, Bank, and others party thereto, and the Trademark Security Agreement dated as of March 8, 2016 ("Trademark Security Agreement") recorded at the United States Patent and Trademark Office ("USPTO") on March 17, 2016 at Reel 5752 Frame 0846, by and between the Grantor and Bank, Grantor mortgaged, pledged and hypothecated to the Bank, and granted to the Bank a security interest in, for its benefit and the benefit of each Secured Party, all Trademark Collateral (as defined in the Trademark Security Agreement), including, but not limited to, the trademarks listed on Schedule A hereto.

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Bank hereby states as follows:

**SECTION 1. Defined Terms.** Capitalized terms used herein without definition shall have the meanings ascribed to such terms in the Security Agreement or Trademark Security Agreement, as applicable.

**SECTION 2. Termination and Release.** Bank hereby:


- (a) absolutely, unconditionally and irrevocably terminates the Trademark Security Agreement;
- (b) absolutely, unconditionally and irrevocably terminates, cancels, forever discharges, and releases the mortgage, pledge, and hypothecation and security interest in all Trademark Collateral, including, but not limited to, the trademarks listed on Schedule A attached hereto;
- (c) represents and warrants that it has full authority to execute and deliver this Release; and
- (d) authorizes the recordation of this Release with the USPTO at Grantor's expense.

**SECTION 3. Further Assurances.** Bank, at Grantor's expense, hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the security interest release contemplated herein. To the extent that any other filings with any other governmental authority have been made with respect to any of the Trademark Collateral, Bank will, at Grantor's expense, execute and deliver a reasonable release or other instrument that will terminate any such filing and/or release any interests conveyed therein.

**IN WITNESS WHEREOF**, the Bank has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
