RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this "Release") is made as of August 19, 2022, by CAPITAL ONE, NATIONAL ASSOCIATION, as agent (in such capacity, together with its successors and permitted assigns in such capacity, "Agent") for the Secured Parties (as defined in the Credit Agreement referred to below). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Credit Agreement or the Trademark Security Agreements (each as defined below), as applicable.

W I T N E S S E T H:

WHEREAS, Belmont Instrument, LLC, a Massachusetts limited liability company ("Grantor"), Agent and certain other parties have entered into that certain Credit Agreement, dated December 15, 2017 (as from time to time amended, restated, supplemented or otherwise modified, the "Credit Agreement");

WHEREAS, Grantor and Agent are parties to that certain Trademark Security Agreement dated as of December 15, 2017 (the "Initial Trademark Security Agreement") and that certain Trademark Security Agreement dated as of June 18, 2018 (the "First Amendment Trademark Security Agreement", and collectively with the Initial Trademark Security Agreement, the "Trademark Security Agreements", and each individually, a "Trademark Security Agreement"), pursuant to each of which Grantor granted to Agent a lien on and security interest in, to and under the Trademark Collateral (as defined in each Trademark Security Agreement) as security for the Secured Obligations;

WHEREAS, the Initial Trademark Security Agreement was recorded by the Assignment Recordation Branch of the United States Patent and Trademark Office on December 15, 2017, at Reel 6230, Frame 0345, and the First Amendment Trademark Security Agreement was recorded by the Assignment Recordation Branch of the United States Patent and Trademark Office on June 21, 2018, at Reel 6360, Frame 0532; and

WHEREAS, Grantor has satisfied the terms of each of the Trademark Security Agreements and has requested that Agent release its lien on and security interest in, to and under the Trademarks and all Trademark Collateral and reassign any and all rights in the same to Grantor.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its lien on and security interest in, to and under all of Grantor's right, title and interest in, to and under the Trademark Collateral, which includes but is not limited to the following:

- (a) all of its Trademarks, registrations and all applications for registration thereof and all Trademark Licenses providing for the grant by or to Grantor of any right under any Trademark, including, without limitation, those referred to on Schedule 1 hereto;
- (b) all of the goodwill of the business connected with the use of, and symbolized by, each such Trademark;
- (c) all renewals and extensions of the foregoing; and
- (d) all income, royalties, proceeds and liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all claims, causes of action,

and rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, any and all of Agent's right, title and interest in, to and under the Trademark Collateral. Agent hereby authorizes Grantor (or its designee) to file this Release with the United States Patent and Trademark Office.


3. Agent agrees to take all further actions, and provide to Grantor and its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor's sole cost and expense, to more fully and effectively effectuate the purposes of this Release.

4. This Release shall be governed by, and construed in accordance with, the law of the State of New York.
