

#### SECOND LIEN INTELLECTUAL PROPERTY SECURITY AGREEMENT

THIS SECOND LIEN INTELLECTUAL PROPERTY SECURITY AGREEMENT, dated as of September 6, 2022 (this "<u>Agreement</u>"), is made by each of the signatories hereto (together with any other entity that may become a party hereto as provided herein, the "<u>Grantors</u>"), in favor of Freedom 3 Capital, LLC, a Delaware limited liability company ("<u>F3C</u>"), as collateral agent (in such capacity, together with its successors and assigns in such capacity, the "<u>Collateral Agent</u>"), acting pursuant to this Agreement for the benefit of the Secured Parties (as defined in the Credit Agreement referred to below).

#### WITNESSETH:

WHEREAS, pursuant to the Second Lien Credit Agreement, dated as of September 6, 2022 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), among AT Denmark Investments ApS, a Danish private limited liability company ("AT Denmark"), Beckett Collectibles Holdings, LLC, a North Carolina limited liability company ("Beckett Collectibles Holdings"), and Southern Hobby Distribution, LLC, a Delaware limited liability company ("Southern Hobby", together with AT Denmark and Beckett Collectibles Holdings, each a "Borrower" and, collectively, the "Borrowers"), certain Subsidiaries and Affiliates of the Borrowers signatory thereto as "Guarantors" or thereafter designated as "Guarantors" pursuant to Section 9.10 of the Credit Agreement, the lenders from time to time party thereto (each a "Lender" and, collectively, the "Lenders"), F3 Baseball, LLC, a Delaware limited liability company ("F3 Baseball"), as administrative agent for the Lenders (in such capacity, together with its successors and assigns in such capacity, the "Administrative Agent"), and the Collateral Agent (the Collateral Agent, together with the Administrative Agent, collectively, the "Agents" and each an "Agent"), the Lenders have severally agreed to make the Loans and other financial accommodations to the Borrowers upon the terms and subject to the conditions set forth therein;

WHEREAS, pursuant to the Second Lien Guarantee Agreement, dated as of the date hereof (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, and together with any other such agreement at any time executed and delivered to the Collateral Agent by any other Guarantor, the "Guarantee Agreement"), delivered by the Guarantors party thereto in favor of the Collateral Agent, such Guarantors have guaranteed the payment and performance of the Borrowers' obligations and liabilities under the Credit Agreement as more fully set forth therein;

WHEREAS, the Borrowers are each a member of an affiliated group of companies and each Grantor, other than the Borrowers, is a Subsidiary or an Affiliate of the Borrowers;

WHEREAS, the proceeds of the Loans and other financial accommodations under the Credit Agreement shall be used, among other purposes, in part to consummate certain acquisitions after the Closing Date and in part for general working capital;

WHEREAS, the Borrowers and the other Grantors are engaged in related businesses, and each Grantor will derive substantial direct and indirect benefits from the making of the Loans and other financial accommodations under the Credit Agreement;

WHEREAS, it is a condition precedent to the obligation of the Lenders to make and continue making their respective Loans and other financial accommodations to the Borrowers under the Credit Agreement that the Grantors shall have executed and delivered the Security Agreement (as defined below) to the Collateral Agent for the benefit of the Secured Parties; and

WHEREAS, pursuant to that certain Second Lien Security Agreement, dated as of the date hereof, by and among the Grantors and the Collateral Agent (the "Security Agreement"), the Grantors agree to duly execute and deliver, and have recorded, such further instruments and documents and take such further actions as the Collateral Agent may reasonably request for the purpose of obtaining or preserving the full benefits of the Security Agreement and of the rights and powers therein granted;

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor hereby agrees as follows:

- 1. <u>DEFINED TERMS</u>. All initially capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement or the Credit Agreement, as applicable.
- 2. <u>GRANT OF SECURITY INTEREST IN INTELLECTUAL PROPERTY COLLATERAL</u>. Each Grantor hereby unconditionally grants, assigns, and pledges to the Collateral Agent, on behalf of and for the ratable benefit of the Secured Parties, to secure the Obligations, a continuing security interest (referred to in this Agreement as the "<u>Security Interest</u>") in all of such Grantor's right, title and interest in and to the following, whether now owned or hereafter acquired or arising (collectively, the "<u>Intellectual Property Collateral</u>"):
- (a) all rights, priorities and privileges relating to intellectual property, now owned or hereafter acquired and owned by such Grantor, whether arising under United States, multinational or foreign laws or otherwise, including, without limitation, the Copyrights, the Copyright Licenses, the Patents, the Patent Licenses, the Trademarks, the Trademark Licenses, and all rights to sue at law or in equity for any infringement or other impairment thereof, including the right to receive all proceeds and damages therefrom;
- (b) (i) all copyrights arising under the laws of the United States, any other country or any political subdivision thereof, whether registered or unregistered and whether published or unpublished (including, without limitation, those listed in <u>Schedule 1</u>, as such schedule may be amended from time to time), all registrations and recordings thereof, and all applications in connection therewith, including, without limitation, all registrations, recordings and applications in the United States Copyright Office and (ii) the right to obtain all renewals thereof;
- (c) any written agreement naming any Grantor as licensor or licensee (including, without limitation, those listed in <u>Schedule 1</u>, as such schedule may be amended from time to time), granting any right under any Copyright, including, without limitation, the grant of rights to manufacture, distribute, exploit and sell materials derived from any Copyright;

- (d) (i) all letters patent of the United States, any other country or any political subdivision thereof, all reissues and extensions thereof and all goodwill associated therewith, including, without limitation, any of the foregoing referred to in **Schedule 1**, as such schedule may be amended from time to time, (ii) all applications for letters patent of the United States or any other country and all divisions, continuations and continuations-in-part thereof, including, without limitation, any of the foregoing referred to in **Schedule 1**, as such schedule may be amended from time to time and (iii) all rights to obtain any reissues or extensions of the foregoing;
- (e) all agreements, whether written or oral, providing for the grant by or to any Grantor of any right to manufacture, use or sell any invention covered in whole or in part by a Patent, including, without limitation, any of the foregoing referred to in **Schedule 1**, as such schedule may be amended from time to time;
- (f) (i) all trademarks, trade names, corporate names, company names, business names, fictitious business names, trade styles, service marks, logos and other source or business identifiers, and all goodwill associated therewith, now existing or hereafter adopted or acquired, all registrations and recordings thereof, and all applications in connection therewith, whether in the United States Patent and Trademark Office or in any similar office or agency of the United States, any State thereof or any other country or any political subdivision thereof, or otherwise, and all common-law rights related thereto, including, without limitation, any of the foregoing referred to in **Schedule 1**, as such schedule may be amended from time to time and (ii) the right to obtain all extensions or renewals thereof;
- (g) any agreement, now or hereafter in effect, whether written or oral, providing for the grant by or to any Grantor of any right to use any Trademark, including, without limitation, any of the foregoing referred to in **Schedule 1**, as such schedule may be amended from time to time;
- (h) all products and proceeds (as that term is defined in the UCC) of the foregoing, including any claim by any Grantor against third parties for past, present or future (i) infringement or dilution of any Copyright, Patent or Trademark or any Copyrights, Patents or Trademarks exclusively licensed under any License, including right to receive any damages, (ii) injury to the goodwill associated with any Trademark, or (iii) right to receive license fees, royalties, and other compensation under any License of Copyrights, Patents or Trademarks.
- 3. <u>SECURITY FOR OBLIGATIONS</u>. This Agreement and the Security Interest created hereby secures the payment and performance of the Obligations, whether now existing or arising hereafter. Without limiting the generality of the foregoing, this Agreement secures the payment of all amounts which constitute part of the Obligations and would be owed by any Grantor to the Lenders whether or not they are unenforceable or not allowable due to the existence of bankruptcy or other insolvency proceeding involving such Grantor.
- 4. <u>SECURITY AGREEMENT</u>. The Security Interest granted pursuant to this Agreement is granted in conjunction with the security interests granted to the Collateral Agent, on behalf of and for the ratable benefit of the Secured Parties, pursuant to the Security Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of the

Collateral Agent and the Lenders with respect to the Security Interest in the Trademark Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein. To the extent there is any inconsistency between this Agreement and the Security Agreement, the Security Agreement shall control.

- 5. <u>AUTHORIZATION TO SUPPLEMENT</u>. If any Grantor shall obtain rights to any new Trademarks, Trademark Licenses, Patents, Patent Licenses, Copyrights or Copyright Licenses the provisions of this Agreement shall automatically apply thereto. No failure of either party to modify this Agreement or amend <u>Schedule 1</u> shall in any way affect, invalidate or detract from the Collateral Agent's continuing security interest in all Collateral, whether or not listed on <u>Schedule 1</u>.
- 6. <u>COUNTERPARTS</u>. This Agreement may be executed by one or more of the parties to this Agreement on any number of separate counterparts (including by telecopy, PDF and/or in any other electronic form), and all of said counterparts taken together shall be deemed to constitute one and the same instrument.
- 7. <u>GOVERNING LAW</u>. THIS AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAW OF THE STATE OF NEW YORK, WITHOUT REFERENCE TO CONFLICTS OF LAW PROVISIONS.
- 8. <u>INCORPORATION OF CREDIT AGREEMENT PROVISIONS</u>. Sections 12.03, 12.04 and 13.19 of the Credit Agreement are hereby incorporated into this Agreement by reference and shall have the same force and effect as if expressly set forth herein.
- 9. <u>INCORPORATION OF SECURITY AGREEMENT PROVISIONS</u>. Article 7 of the Security Agreement is hereby incorporated into this Agreement by reference and shall have the same force and effect as if expressly set forth herein.
