TRADEMARK ASSIGNMENT

This Trademark Assignment (“**Agreement**”) is made effective as of August 16, 2022 (“**Effective Date**”), and is entered into by and between Pamela “Mia” Richardson, an individual (hereinafter known as “**Assignor**”) and Spa Living Showrooms, Inc., a Washington corporation (hereinafter “**Assignee**”). For purposes of this Agreement, Assignor and Assignee may be referred to individually as a “**Party**,” and collectively as the “**Parties**.”

WHEREAS, Assignor owns an undivided one half interest in the common law and registered rights in the trademark SPALENA (also sometimes spelled SpaLena), in connection with “massage table linens, namely, sheets, quilted blankets, face cradle covers; textile goods, namely, bed linens, bed sheets, bed blankets, quilted bed blankets, duvets, duvet covers,” together with United States Trademark Registration Number 3837476 therefor, (hereinafter, collectively, the “**Trademark**”), and the goodwill of the business symbolized by the Trademark; and

WHEREAS, Assignee desires to acquire ownership of the Trademark from Assignor and Assignor desires to transfer the Trademark to Assignee.

NOW THEREFORE, in consideration of the mutual covenants herein and in the Trademark Purchase and Assignment Agreement concurrently executed by the Parties, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns and transfers to Assignee all of Assignor’s right, title and interest in and to the Trademark together with the goodwill of the business symbolized thereby, or portion thereof, to which the mark pertains, and together with all claims for damages by reason of past and future infringement thereof or act of unfair competition relating thereto, with the right to sue for damages, and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns, and legal representatives.

All of the recitals referred to in this Agreement are made a part hereof and incorporated in this Agreement by this reference.

IN WITNESS WHEREOF, the Parties have executed this Agreement effective as of the first date appearing hereinabove.


