CONFIRMATORY TRADEMARK AND COPYRIGHT ASSIGNMENT

Confirmatory Trademark and Copyright Assignment by **CTC Tech Connect, Inc.**, a New York nonprofit corporation ("CTC") and **Aglío E Olio LLC**, a New York limited-liability company ("Aglío"). both located at 86 Thomas Street, 5th Floor, New York, NY 10013, Attention Anjali Kumar (jointly and severally sometimes referred to as "an Assignor" or "Assignors"), to **The Giving Back Fund, Inc.**, a Massachusetts nonprofit corporation ("GBF"), of 5101 Santa Monica Blvd Ste 8 PMB 137, Los Angeles, CA. (sometimes referred to as "Assignee").

- A. CTC has adopted, used and is using the mark **TELEHOME** (the "Mark"), U. S. Registration No. 6703114 registered April 12, 2022 (the "Trademark Registration");
- B. CTC claimed ownership of the artwork for a computer application (the "App Artwork") adopted and used on and in connection with the Mark, including the unregistered copyright in the App Artwork;
- C. CTC signed a Trademark and Copyright Assignment dated July 5, 2022 and recorded in the U.S. Patent and Trademark Office against the Trademark Registration, Recordation No. 900713365, Reel/Frame 7780/0146, recordation Date July 8, 2022 (the "July 2022 Assignment") purporting to assign to Aglio all of CTC's right, title and interest in and to the Mark and the Trademark Registration, the goodwill of the business symbolized by it, and the App Artwork;
- D. The July 2022 Assignment to Aglio was made in error; and
- E. Assignors now wish to correct the error by transferring to GBF all of each Assignor's right, title and interest, if any, in and to the Mark and the Trademark Registration, the goodwill of the business symbolized by the Mark, and the App Artwork and the copyright in it, effective as of July 5, 2022, which is the date of the July 2022 Assignment.

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

- 1. **Trademark Assignment.** Each Assignor hereby assigns, transfers and conveys unto Assignee, its successors and assigns, absolutely and forever, all of that Assignor's common law and statutory right, title and interest, if any, in and to the Mark for all goods and services, worldwide, together with the goodwill of the business symbolized by it, and any and all applications for it and registrations of it, including **U. S. Registration No. 6703114 registered April 12, 2022**, as well as the right to file and prosecute applications to register the Mark and the right to take legal actions against infringements occurring either before or after the effective date of this assignment and to collect and retain all monetary and other benefits derived from such actions, effective as of July 5, 2022, which is the date of the July 2022 Assignment.
- 2. **Copyright Assignment.** Each Assignor hereby assigns, transfers and conveys unto Assignee, its successors and assigns, absolutely and forever, all of Assignor's rights, title and interest, if any, in and to the App Artwork (including all aspects created by employees of that Assignor acting within the scope of their employment, and all aspects created by Butter


Studio LLC (“Butter”), which were previously purported to be assigned by Butter to GBF pursuant to a Design Contract dated November 23, 2020, were thereafter purported to be assigned by GBF to CTC pursuant to a Confirmatory Copyright Assignment dated July 5, 2022 effective as of June 1, 2022, and thereafter were purported to be assigned by CTC to Aglio pursuant to the July 2022 Assignment), and all copyrights and any other intellectual property rights, worldwide, as well as all renewals and extensions of those copyrights, and all physical copies of the App Artwork, and the right to take legal actions against infringements occurring either before or after the effective date of this assignment and to collect and retain all monetary and other benefits derived from such actions, effective as of July 5, 2022, which is the date of the July 2022 Assignment. Assignee, its successors and assigns, will have the absolute right to use the App Artwork in all media now or hereafter known, with or without modification or attribution.
