RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “Release”), dated as of 17 August, 2022, is executed by **WELLS FARGO CAPITAL FINANCE (UK) LIMITED** (“Security Trustee”), in favor of **PHAIDON INTERNATIONAL (UK) LTD**, a company incorporated under the laws of England and Wales with registered number 05134675, (the “Obligor”). All capitalized terms used in this Release and not otherwise defined herein, shall have the respective meanings given to such terms in the Security and Pledge Agreement (as defined below).

RECITALS

A. WHEREAS, the Obligor has pursuant to that certain Security and Pledge Agreement dated August 14, 2018, recorded in the United States Patent and Trademark Office (the “USPTO”) October 5 2020 at Reel 7071, Frame 0128 (as the same may be amended, amended and restated, restated, supplemented, modified or otherwise in effect prior to the date hereof, the “Security and Pledge Agreement”) granted to Security Trustee a Security Interest in and to all of the Obligor’s rights, titles and interests in and to the Trademark, including without limitation the trademark listed on Exhibit A attached hereto (the “Released Collateral”); and

B. WHEREAS, the Security Trustee wishes to terminate and release, without representation or warranty, its Security Interest in and to the Released Collateral as provided in this Release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the Security Trustee hereby terminates and releases, without representation or warranty, its Security Interest in and to the Released Collateral and terminates the Security and Pledge Agreement. The Security Trustee acknowledges that this Release may be filed along with any other necessary documentation with the USPTO or any other governmental office to evidence the release granted herein at the sole expense of the Obligor. The Security Trustee authorizes the Obligor and its designees to record this Release with the USPTO and other applicable registry at the sole expense of the Obligor and agrees to provide the Obligor with any information and additional authorization necessary to effect the release of the Security Interest in the Released Collateral.

This Release may be executed by means of (a) an electronic signature that complies with the federal Electronic Signatures in Global and National Commerce Act, state enactments of the Uniform Electronic Transactions Act, or any other relevant and applicable electronic signatures law; (b) an original manual signature; or (c) a faxed, scanned, or photocopied manual signature. Each electronic signature or faxed, scanned, or photocopied manual signature shall for all purposes have the same validity, legal effect, and admissibility in evidence as an original manual signature.
