Nunc Pro Tunc Trademark and Domain Name Assignment Agreement

WHEREAS, Soapbox Financial Network, LLC, a Delaware limited liability company (“**Assignor**”), with its principal offices at 2000 Duke Street, 4th Floor, Alexandria, Virginia 22314 owned all rights, title, and interest in and to the PENNY PINCHIN’ MOM trademark and corresponding United States trademark registration (U.S. Trademark Reg. 

WHEREAS, the conveyance of the rights, title, and interest in and to the PENNY PINCHIN’ MOM Mark and Domain to the Assignee was not memorialized in writing.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, this *nunc pro tunc* assignment is being executed by Assignor and Assignee to clarify ownership of the PENNY PINCHIN’ MOM Mark and Domain, and to confirm that Assignor did assign unto the Assignee all rights, title, and interest in and to the PENNY PINCHIN’ MOM Mark and Domain, together with the portion of Assignor’s ongoing and existing business to which the PENNY PINCHIN’ MOM Mark pertained and all goodwill associated with and symbolized by the PENNY PINCHIN’ MOM Mark.

IN WITNESS WHEREOF, Assignor and Assignee wish to confirm, reaffirm, and record the assignment of the PENNY PINCHIN’ MOM Mark and Domain.


