## **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of August 22, 2022 ("Release"), is made by Alter Domus (US) LLC, as Successor Collateral Agent ("Successor Collateral Agent") to Pinebridge Private Credit Agent LLC, as Administrative Agent ("Prior Agent"), in favor of Phaidon International (UK) LTD, a United Kingdom private limited company ("Obligor").

**WHEREAS**, pursuant to that certain Security and Pledge Agreement dated as of April 3, 2018 (as amended, modified, supplemented, increased, extended, restated, renewed, refinanced or replaced from time to time, the "Security Agreement") by and among the Obligor, Prior Agent, and others party thereto, Obligor granted to Prior Agent, for the benefit of the holders of the Secured Obligations, a continuing security interest in any and all right, title and interest of Obligor in and to all Trademarks, including the trademark registrations and trademark applications listed on Schedule 1 attached hereto (collectively, the "Trademark Collateral");

**WHEREAS**, pursuant to the Security Agreement, Grantor executed and delivered to Administrative Agent the Notice of Grant of Security Interest in Trademarks recorded at the United States Patent and Trademark Office ("USPTO") on October 5, 2020 at Reel 7068 Frame 0637 ("Trademark Notice"), the Form MM19 (E) recorded at the World Intellectual Property Office ("WIPO") on June 3, 2021 in Gazette: 2021/20 ("WIPO Form"), and the Form TM24 recorded at the United Kingdom Intellectual Property Office ("UKIPO") on October 5, 2020 at Security No. RC000162255 ("UK Form");

**WHEREAS**, pursuant to the Notice of Successor Collateral Agent and Assignment of Security Interest (Intellectual Property) dated as of April 15, 2021 ("Successor Notice") by and among Prior Agent and Successor Collateral Agent, Prior Agent ceased to be the Collateral Agent under the Assigned Loan Documents and was succeeded to and replaced by Successor Collateral Agent as Collateral Agent under the Assigned Loan Documents including the Trademark Notice; and

**WHEREAS**, the Successor Notice was recorded at the USPTO on April 15, 2021 at Reel 7256 Frame 0962, the Form MM19 (E) pursuant to the Successor Notice was recorded at the WIPO on July 1, 2021 in Gazette: 2021/24 ("Successor WIPO Form"), and a new Form TM24 was recorded at the UKIPO on April 30, 2021 at Security No. RC000204670 ("Successor UK Form");

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Successor Collateral Agent, on behalf of the holders of the Secured Obligations, and Obligor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement, Trademark Notice, or Successor Notice, as applicable.

**SECTION 2. Termination and Release.** Successor Collateral Agent, on behalf of the holders of the Secured Obligations, without any representation, warranty, recourse, or undertaking of any kind (whether express or implied), hereby:

(a) terminates, cancels, discharges, and releases the continuing security interest in any and all right, title and interest of Obligor in and to all Trademark Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement, Trademark Notice, WIPO Form, UKIPO Form, Successor Notice, Successor WIPO Form, or Successor UK Form; and

(b) authorizes the recordation of this Release with the USPTO or other governmental office at Obligor's expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.
