TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (this "Agreement") is entered into as of August 10, 2022 ("Effective Date") by and between Indegene Healthcare LLC, a New Jersey limited liability company ("Assignor"), and Indegene, Inc., a Delaware corporation ("Assignee").

WHEREAS, Assignor desires to assign, and Assignee desires to acquire, the mark listed in Exhibit A (the "Mark") and all rights in the Mark, including the goodwill of the business associated with the Mark, as well as any and all common law rights in the Mark, and the trademark registration associated with the Mark.

NOW THEREFORE, for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignment. Assignor hereby conveys, transfers, and assigns to Assignee all right, title, and interest in and to the Mark, including but not limited to all common law rights in the Mark and the registration for the Mark, together with the goodwill of Assignor's business connected with the use of and symbolized by the Mark, and all rights corresponding thereto throughout the world. Assignor further assigns to Assignee all rights to sue for and receive all damages occurring from past infringing uses of the Mark.

2. Further Assurances. Assignor agrees that at any time and from time to time after execution of this Agreement, at the request of Assignee and without further consideration, Assignor will execute and deliver such other instruments and take such action as Assignee may reasonably request to transfer, convey, and assign to Assignee, and to confirm Assignee's right, title, and interest in and to the Mark, and to assist Assignee in exercising all rights with respect to the Mark.

3. General Terms. Nothing in this Agreement, express or implied, is intended or will be construed to confer upon, or give to, any person or entity, other than the parties to this Agreement, any rights, remedies, obligations, or liabilities. This Agreement will bind and inure to Assignee and Assignor and their respective successors and assigns. This Agreement may be executed in any number of counterparts, each of which will be deemed an original, but all of which together will constitute one and the same. Facsimile or electronic signatures shall be deemed original signatures.

IN WITNESS WHEREOF, the undersigned parties have executed this Trademark Assignment Agreement by and through their properly authorized signatories effective as of the Effective Date.
