**CONFIRMATORY SECURITY AGREEMENT**

**WHEREAS** a certain general security agreement dated as of August 10, 2022 (as same may be amended, supplemented, restated, replaced or otherwise modified from time to time, the "GSA") entered between, *inter alios*, Alida Inc. (the "Grantor") and National Bank of Canada (the "Administrative Agent"), for the benefits of the Lenders (as such term is defined in the GSA), pursuant to which the Grantor granted in favour of the Administrative Agent, a security interest in, among other things, the universality of all the intellectual property now owned or held by the Grantor or of which it is an authorized user or which the Grantor shall hereafter become an authorized user, together with all of the Grantor's rights, titles and interests therein (collectively, the "Intellectual Property").

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantor hereby confirms and agrees that the security interest created under the GSA has attached to the Intellectual Property, including, without limitation, the Intellectual Property listed in Schedule "A" attached hereto, and that the Intellectual Property and all proceeds thereof are subject to the GSA, all as more fully set forth in the GSA. The Grantor also agrees to execute and deliver to the Administrative Agent all such further documents and assurances from time to time as the Administrative Agent may reasonably consider necessary or desirable in connection with the foregoing.

**NOW THEREFORE**, the parties agree that this Confirmatory Security Agreement has been executed by the parties hereto for purposes of being recorded with the Canadian Intellectual Property Office and with the United States Patent and Trademark Office.


