RELEASE OF SECURITY INTERESTS IN PATENTS AND TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN PATENTS AND TRADEMARKS (this “Release”) dated as of [September 2], 2022 is executed by PERCEPTIVE CREDIT HOLDINGS II, LP, as administrative agent for the Secured Parties (in such capacity, the “Administrative Agent”), in favor of MONTERIS MEDICAL CORPORATION, a Delaware corporation (the “Grantor”).

RECITALS

A. WHEREAS, pursuant to that certain Patent and Trademark Security Agreement dated as of March 6, 2019 made by Grantor in favor of Administrative Agent (the “IP Security Agreement”), the Grantor has granted to Administrative Agent a security interest in and to all of the Grantor’s right, title and interest in and to certain the trademarks, including those trademarks listed on Exhibit A attached hereto, and certain patents, including those patents listed on Exhibit B, attached hereto;

B. WHEREAS, pursuant to that certain Patent Security Agreement dated as of August 21, 2020, made by Grantor in favor of Administrative Agent (the “Patent Security Agreement”), the Grantor has granted to Administrative Agent a security interest in and to all of the Grantor’s right, title and interest in and to certain patents, including those patents listed on Exhibit C attached hereto (collectively, with the patents and trademarks referenced in the IP Security Agreement, the “Released Collateral”);

C. WHEREAS, the IP Security Agreement was recorded in the United States Patent and Trademark Office (the “USPTO”) on March 7, 2019, at Reel 6584, Frame 0238, with respect to the trademarks listed on Exhibit A attached hereto;

D. WHEREAS, the IP Security Agreement was recorded in the USPTO on March 7, 2019, at Reel 48528, Frame 0896, with respect to the patents listed on Exhibit B attached hereto;

E. WHEREAS, the Patent Security Agreement was recorded in the USPTO on August 21, 2020, at Reel 053571, Frame 0984, with respect to the patents listed on Exhibit C attached hereto; and

F. WHEREAS, Administrative Agent wishes to terminate and release, without representation or warranty, its security interest in and to the Released Collateral as provided in this Release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Administrative Agent hereby terminates the IP Security Agreement and the Patent Security Agreement, and terminates and releases, without representation or warranty, its security interest in and to the Released Collateral, including all of Grantor’s right, title, and interest in, to and under all of the following:

(i) all patents and patent applications, in each case whether now owned by Grantor or hereafter acquired and whether now existing or hereafter coming into existence,

including without limitation those listed on Exhibit B and Exhibit C hereto, and all related patents and applications thereto, including all reissuances, continuations, continuations-in-part, revisions, extensions, re-examinations thereof, any patents and patent applications claiming priority to said patents and patent applications or from which said patents and patent applications claim priority, and pending applications associated therewith; and

(ii) all of the trademarks, whether now owned or at any time hereafter acquired, of Grantor that are registered with, or for which applications for registration have been filed with, the United States Patent and Trademark Office, including the trademarks listed on Exhibit A hereto, and all registrations and pending applications associated therewith.




