RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS ("Release") is made as of this 30th day of October, 2020, by MARANON CAPITAL, L.P., as administrative agent ("Administrative Agent"), in favor of RIMKUS CONSULTING GROUP, INC., a Texas corporation ("Company").

WHEREAS, Administrative Agent and Company were parties to that certain Trademark Security Agreement dated as of December 20, 2018 (the "Trademark Security Agreement"), pursuant to which Company granted a security interest to Administrative Agent in the Trademark Collateral (as defined in the Trademark Security Agreement) as security for certain obligations owing by Company to Administrative Agent, including the Trademarks listed on Schedule A attached hereto; and

WHEREAS, the Trademark Security Agreement was executed by Company in favor of Administrative Agent and recorded with the United States Patent and Trademark Office on December 20, 2018 at Reel/Frame 6505/0805; and

WHEREAS, Company has requested that Administrative Agent release its security interest in and lien on all of Grantor's right, title and interest in, to and under the Trademark Collateral and reassign the same to Grantor.

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged:

1. Administrative Agent hereby releases all liens and security interests granted by Company in favor of Administrative Agent in the trademarks listed on Schedule A.

2. Administrative Agent hereby reassigns, grants and conveys to Company, without any representation, recourse or undertaking by Administrative Agent, all of Administrative Agent's right, title and interest in and to the Trademark Collateral.

3. Administrative Agent hereby further authorizes and consents that this release may be recorded and indexed by the Commissioner of Trademarks of the United States Patent and Trademark Office.
