TRADEMARK ASSIGNMENT AGREEMENT

Assignor will, at the reasonable request of Assignee and without demanding any further consideration therefor, do all things necessary, proper, or advisable, including without limitation the execution, acknowledgment and recordation of specific assignments, oaths, declarations and other documents on a country-by-country basis, to assist Assignee in obtaining, perfecting, sustaining, and/or enforcing the Trademarks and the assignment contemplated hereby.

This Assignment is binding on the parties hereto and their respective successors and assigns, and inures to the benefit of the Assignee and its successors and assigns.
