DECLARATION IN SUPPORT OF CORRECTIVE ASSIGNMENT

The current owner of the U.S. trademark registrations listed above and in Exhibit A of the Corrective Assignment (the “Registrations”) submitted herewith is Nortek Security & Control LLC (formerly Linear LLC). While the Registrations currently list Linear LLC as the current owner of record,¹ Linear LLC changed its name to Nortek Security & Control LLC as further discussed below. Since Linear LLC is the same entity as Nortek Security & Control LLC and the same entity has been and continues to be the owner of the Registrations, Nortek Security & Control LLC respectfully submits this Corrective Assignment and Declaration to reflect the correct owner entity name for the Registrations.

On January 11, 2019, the assignment agreement with an effective date of November 27, 2018 transferring ownership of the Registrations from GTO Access Systems, LLC to Linear LLC was filed with the USPTO Assignment Recordation Branch (Reel/Frame: 6523/0109) (the “Assignment”). However, due to a clerical error, the Assignment indicated “Linear LLC” as the

No. 3900349 as well to correct the clerical error in the initial assignment filed on January 11, 2019 (Reel/Frame: 6523/0109) discussed herein.

Assignee name rather than “Nortek Security & Control LLC.” Since Linear LLC had previously changed its entity name to Nortek Security & Control LLC on December 11, 2014, which is evidenced by the Change of Name filed with the USPTO’s Assignment Recordation Branch on February 1, 2019 (Reel/Frame: 6547/0955), the correct Assignee name should have been Nortek Security & Control LLC.

Given Linear LLC was the former name of Nortek Security & Control LLC and the two entities are the same entity (evidencing the fact that the same entity has been and continues to be the owner of the Registrations), Registrant respectfully submits the subject Corrective Assignment and Declaration to rectify the foregoing clerical error and replace “Linear LLC” in the prior Assignment with the correct, updated entity name “Nortek Security & Control LLC.” In accordance with TMEP 503.06(b), this correction to the Assignment does not change the nature of the prior assignment in any way because Linear LLC and Nortek Security & Control LLC are the same entity.

Accordingly, Registrant respectfully requests that the current owner information for the Registrations be corrected to properly reflect “Nortek Security & Control LLC” as the owner of the Registrations as reflected in the Corrective Assignment.
