Pursuant to RCW 23B.11.090, the following Articles of Merger are executed for the purpose of merging each of Nandorf, LLC, a Washington limited liability company (the "*WA Disappearing Entity*"), and Unique Thrift, LLC, a Delaware limited liability company (the "*DE Disappearing Entity*") into TVI, Inc., a Washington corporation (the "*Surviving Entity*").

1. The Agreement and Plan of Merger was duly approved by the sole member of the WA Disappearing Entity pursuant to the applicable laws of the State of Washington as required by RCW 25.15.421.

2. The Agreement and Plan of Merger was duly approved by the sole member of the DE Disappearing Entity pursuant to the applicable laws of the State of Delaware as required by RCW 23B.11.070.

3. Approval of the Agreement and Plan of Merger by the shareholders of the Surviving Corporation was not required pursuant to RCW 23B.11.030(7).

4. The merger shall be effective at 8:59 p.m. Pacific Daylight Time on August 28, 2022.
