
NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, as of July 29, 2022 (the “Effective Date”), SELLER does hereby assign, sell, transfer, and set over to PURCHASER all rights, title, and interest in and to each of the Trademarks, any and all priorities, good will and common law rights associated with the Trademarks, and all convention and treaty rights of all kinds in all countries of the world with respect to the foregoing, all the aforementioned property rights (collectively, the “Assigned Intellectual Property”) to be held and enjoyed by PURCHASER for its own use, benefit and behalf and for the use, benefit, and behalf of PURCHASER’s successors, assigns and other legal representatives as fully and entirely as the same would have been held and enjoyed by SELLER or ULTIMATE GAMER, if this assignment had not been made, together with all claims for damages by reason of past infringement of the Assigned Intellectual Property once used and with the right to sue for and collect the same for PURCHASER’s use and behalf and for the use and behalf of PURCHASER’s successors, assigns and other legal representatives.


