WHEREAS, Assignor owns the trademark (the "Mark") and the corresponding registration (the "Registration") listed on the attached Schedule A;


WHEREAS, Assignee desires to acquire all rights to the Mark, the Registration, and the goodwill of the business symbolized by the Mark;
