## Background

- A. Pursuant to a Sale and Purchase Agreement executed on about 16 December 2020, the Assignor transferred, assigned and set over to the Assignee all of its rights, title and interest in the Trade Marks.

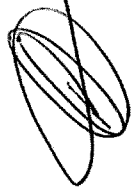
