

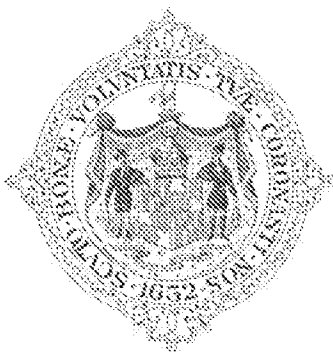

SECOND: The charter is hereby amended by deleting Article SECOND in its entirety and inserting the following in place thereof:


The name of the corporation is "Rendia, Inc." (the "Corporation").


