**CANADIAN INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This Canadian Intellectual Property Security Agreement dated August 25, 2022 (“Agreement”) is made by each of good natured Products Inc., a corporation incorporated pursuant to the laws of British Columbia, and good natured Products (CAD) Inc., a corporation incorporated pursuant to the laws of British Columbia (each, together with their respective successors and assigns, the “Grantor” and collectively, the “Grantor”).

**WHEREAS**, each Grantor owns the intellectual property set forth in Annex A hereto, the registrations and applications for the intellectual property identified therein and any underlying goodwill associated with such intellectual property (collectively, the “Intellectual Property”);

**WHEREAS**, each Grantor has executed a Canadian guarantee and security agreement dated as of August 25, 2022 (as amended, modified, supplemented, extended, renewed, restated or replaced, the “Security Agreement”) in favour of **WELLS FARGO CAPITAL FINANCE CORPORATION CANADA**, as lender (together with its successors and assigns, “Lender”), pursuant to which each Grantor granted to Lender a security interest in and to its property, including the Intellectual Property; and

**WHEREAS**, each Grantor agrees that this Agreement shall be governed by the laws of the Province of British Columbia and the federal laws of Canada applicable therein.

**NOW THEREFORE**, for other good and valuable consideration, and in accordance with the terms and obligations set forth in the Security Agreement, each Grantor confirms the grant to Lender of a security interest in and to the Intellectual Property and authorizes the filing of this Confirmation with the Canadian Intellectual Property Office, the United States Copyright Office, the United States Patent and Trademark Office and any similar office of any other jurisdiction.
