**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (this “**Release**”) is granted on this 20th day of April, 2022, by BANK OF AMERICA, N.A., (“**BoA**”) a national banking association with an address at One Bryant Park, New York, NY 100036, as the Administrative Agent in favor of CLARK EQUIPMENT COMPANY (the “**Borrower**”) with respect to the Trademarks (as defined below).

W I T N E S S E T H :

WHEREAS, the Borrower and certain other Grantors, and BoA are party to that certain Security Agreement, dated as of May 18, 2017 (as amended, supplemented, restated or otherwise modified from time to time, the “**Security Agreement**”) entered into pursuant to that certain ABL Credit Agreement, dated as of May 18, 2017 (as amended, supplemented, restated or otherwise modified from time to time) by and among DOOSAN BOBCAT INC., the Borrower, BoA, and JP MORGAN CHASE BANK, N.A. and WELLS FARGO BANK, N.A. as Co-Syndication Agents;

WHEREAS, on May 18, 2017, BoA and Borrower entered into a Trademark Security Agreement, which was recorded with the U.S. Patent and Trademark Office (the “**USPTO**”) on June 15, 2017, at Reel/Frame 6085/0190 (the “**2017 Trademark Security Agreement**”);

WHEREAS, on January 30, 2020, BoA and Borrower also entered into the Trademark Security Agreement Supplement No. 1, which was recorded with the USPTO on February 7, 2020, at Reel/Frame 6859/0751; (the “**2020 Trademark Security Agreement**”);

WHEREAS, pursuant to the Security Agreement, the 2017 Trademark Security Agreement and the 2020 Trademark Security Agreement Supplement No. 1 (collectively, the “**Trademark Security Agreements**”), Borrower pledged and granted to BoA a continuing security interest in all of the Borrower’s right, title and interest in, to and under the Trademark Collateral (as defined below);

WHEREAS, BoA desires to release any and all security interests, and any other lien, it has in the Trademark Collateral, and assign all right, title and interest it may have in and to the Trademark Collateral to Borrower.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, BoA hereby agrees as follows:

1. BoA hereby absolutely, unconditionally and irrevocably releases, terminates and forever discharges each security interest in any and all right, title and interest that it may have in, to and under any and all trademarks, service marks, trade names,

brand names, logos, trade dress, design rights and other similar designations of source, whether registered or unregistered, including the trademark registrations and applications set forth in Schedules A and B hereto, together with the goodwill connected with the use thereof and symbolized thereby and all extensions and renewals thereof, and the right to receive all proceeds therefrom, in each case arising under the Security Agreement and the Trademark Security Agreements (collectively, the “**Trademark Collateral**”), and any and all other security interests or liens that BoA or its predecessors, successors and assigns may have in or to the Trademark Collateral under the Security Agreement or the Trademark Security Agreements.

2. BoA hereby terminates and cancels the Trademark Security Agreements.
3. The parties hereto authorize and request the Director of Patents and Trademarks of the United States of America to record this Release against the Trademark Collateral. BoA agrees to perform all further acts and execute and deliver all further documents and/or instruments that may be reasonably necessary to carry out the provisions of this Release.
4. This Release shall be governed by and construed in accordance with the law of the State of New York.
5. This Release shall be binding upon BoA’s representatives, successors, assigns and transferees and other legal representatives (only in their respective capacity as Administrative Agent), and is made in favor of and for the benefit of the Borrower and its successors and assigns.


