**RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL**, dated as of August 31, 2022 (this “Release”), is made by WILMINGTON TRUST, NATIONAL ASSOCIATION, in its capacity as administrative agent pursuant to the Second Lien Credit Agreement (as defined in the Second Lien Security Agreement, defined below) (in such capacity, the “Administrative Agent”), in favor of Output Services Group, Inc., a New Jersey corporation, SouthData, Inc., a North Carolina corporation, DoublePositive Marketing Group, Inc., a Delaware corporation, National Business Systems, Inc., a Minnesota corporation, ClickSpark, LLC, a New York limited liability company, CallVista, LLC, a New York limited liability company, Globalex Corporation, a California corporation, Microdynamics Corporation, an Illinois corporation, Windsor Circle, Inc., a Delaware corporation, Mansell Group, Inc., a Georgia corporation, Applied Information Group, Inc., a New Jersey corporation, NCP Solutions, LLC, a Delaware limited liability company, Paybox Corp, a Delaware corporation, and Applied Revenue Analytics, LLC, a North Carolina limited liability company (individually, a “Grantor”, and, collectively, the “Grantors”). Capitalized terms used and not otherwise defined herein have the meanings given to them in the Second Lien Security Agreement.

**W I T N E S S E T H**

WHEREAS, the Grantors are parties to that certain Second Lien Security Agreement, dated as of September 17, 2019 (as amended, amended and restated, supplemented or otherwise modified from time to time, the “Second Lien Security Agreement”) in favor of the Administrative Agent, for the benefit of the Secured Parties;

WHEREAS, pursuant to the Second Lien Security Agreement, the Grantors executed the Second Lien Trademark Security Agreement, dated as of September 17, 2019 (the “Trademark Security Agreement”) and recorded with the U.S. Patent and Trademark Office on September 18, 2019 at Reel/Frame No. 6748/0585 and on September 19, 2019 at Reel/Frame No. 6749/0027, pursuant to which each Grantor pledged and granted to the Administrative Agent for the benefit of the Secured Parties a lien on and security interest in all of the right, title and interest in, to and under all Trademarks of such Grantor (other than Excluded Assets) (the “Trademark Collateral”);


WHEREAS, each Grantor has requested that the Administrative Agent release its security interest in and to all of its right, title and interest in, to and under the Trademark Collateral;

NOW, THEREFORE, in consideration of the foregoing, the Administrative Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under the Trademark Collateral, including the trademarks registrations and applications set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to each Grantor without recourse, representation or warranty, any and all right, title and interest that the Administrative Agent may have obtained in, to and under the Trademark Collateral under the Second Lien Security Agreement and the Second Lien Trademark Security Agreement.
