Pursuant to Title 8, Section 264 of the Delaware General Corporation Law and Title 6, Section 209 of the Delaware Limited Liability Company Act

Pursuant to Title 8, Section 264 of the Delaware General Corporation Law (the "**DGCL**") and Title 6, Section 209 of the Delaware Limited Liability Company Act (the "**DLLCA**"), the undersigned business entities have executed the following Certificate of Merger:

FIRST: The names of the entities constituent to the merger are DMT Solutions Global Corporation, a Delaware corporation ("**DMT**"), and Fluence Automation LLC, a Delaware limited liability company ("**Fluence**").

SECOND: The Agreement and Plan of Merger has been approved, adopted, certified, executed and acknowledged by each of DMT and Fluence in accordance with Section 264 of Title 8 of the DGCL and Section 209 of Title 6 of the DLLCA.

FOURTH: The Certificate of Incorporation of DMT shall be the Certificate of Incorporation of the surviving corporation.

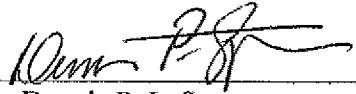
