**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (the "Release") is made as of August 31, 2022, by The Huntington Capital Investment Company, an Ohio corporation ("Lender"), in favor of Salon Lofts Group, LLC, a Delaware limited liability company ("Borrower").

WHEREAS, pursuant to that certain Notice of Security Interest recorded on February 16, 2012, at Reel No. 004718, Frame 0834, United States Patent and Trademark Office, Borrower granted a security interest in certain trademarks in favor of Lender to secure certain debt owing from Borrower to Lender;
