RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”) is effective as of August 24, 2022 and is given by CIBC Bank USA, with principal offices at 120 S. LaSalle Street, Chicago, Illinois 60603, in its capacity as administrative agent for the benefit of the financial institutions (the “Lenders”) that are parties to the Credit Agreement referenced in the Security Agreement referenced below (in such capacity, the “Administrative Agent”), to American Guardian Warranty Services, Inc., an Illinois corporation (“Grantor”).

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of September 28, 2020 (“Security Agreement”), made by Grantor in favor of Administrative Agent, a security interest was granted by Grantor to Administrative Agent in the Trademark Collateral as such term is defined in the Security Agreement;

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent & Trademark Office on September 29, 2020, at Reel 7064, Frame 0630; and

WHEREAS, Grantor desires Administrative Agent to release, discharge, terminate and cancel its lien on and security interest in the portions of the Trademark Collateral listed on Schedule 1 attached hereto (the “Released Collateral”);

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Administrative Agent, on behalf of the Lenders, hereby terminates, releases, and discharges unto Grantor the continuing security interest in, and any other interest Lenders may have in, Grantor’s right, title and interest in, the Released Collateral.

The Administrative Agent authorizes and requests that the Commissioner for Trademarks and any other applicable government officer record this Release.

This Release and its rights and obligations of the parties hereto shall be governed by, and construed and interpreted in accordance with the laws of the State of Illinois.

Capitalized terms used herein without definition have the meanings given to them in the Security Agreement.
