**TERMINATION AND RELEASE OF
TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (“Release”) is made as of this 31st day of August, 2022, by MGG INVESTMENT GROUP LP, in its capacity as administrative agent for each member of the Lender Group (in such capacity, “Agent”), in favor of each of the signatories hereto (collectively, “Grantors”).

WHEREAS, Grantors entered into that certain Trademark Security Agreement, dated April 26, 2021 with Agent, notice of which was recorded with the United States Patent and Trademark Office on April 26, 2021 at reel/frame 7271/0328 (the “Trademark Security Agreement”). Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, each Grantor granted to Agent, under the terms of the Trademark Security Agreement, a security interest in favor of Agent, in and to all of their right, title and interest in and to the Trademark Collateral, including without limitation the Trademarks and Trademark Intellectual Property Licenses to which it is a party listed in Schedule A hereto.

WHEREAS, Agent has agreed to terminate and release its security interest in all such Trademark Collateral as herein provided.


FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, Agent, on behalf of the Lender Group (a) terminates the Trademark Security Agreement and hereby releases, terminates and discharges its security interest in the Trademark Collateral, including the trademarks listed in Schedule A hereto and made a part hereof, and (b) if and to the extent that the Agent has acquired any right, title or interest in and to the Trademark Collateral, the Agent hereby assigns, transfers and conveys to the applicable Grantor all of Agent’s right, title and interest in such Trademark Collateral. This Release shall be governed by and construed in accordance with the laws of the State of New York, without regard to conflicts of law or choice of law principles.
